## Travel Protection Insurance Form

Wise travelers recognize the important need to protect their trip investment, health, and personal belongings. Emergencies can happen when you least expect it, therefore, I highly recommend that you protect your vacation with a travel insurance. Cruise lines, airlines, hotels, and tour operators all have penalties for cancellation, ranging from the full deposit to no refund at all. Also, keep in mind that most health insurance policies may not offer cover you when you are out of the country. Travel Protection Insurance may offer protection in the following areas:

Trip Cancellation  
Trip Delay  
Trip Interruption  
Missed Connection  
Baggage Loss, Theft or Damage  
Baggage Delay  
Emergency Medical and Dental Expenses  
Emergency Medical Transportation  
24/7 Hotline Assistance

Many insurance suppliers do not provide the following coverage:

- Supplier Bankruptcy
- The ability to cancel your trip (for covered reasons) up to the time of departure. (CFAR)
- Trip interruption coverage once you have departed.
- Medical coverage.
- 24-hour hotline assistance for travel and medical emergencies.

Even pre-existing coverage may not apply to world events such as strikes, natural disasters, terrorism, etc. It is your responsibility to obtain insurance BEFORE making your vacation final payment. While I am not a registered insurance agent and cannot legally provide specific advice or information regarding insurance, I can certainly suggest a couple of them.
